CAPE holds the same level of accountability as any other professions.

- ❑ Consider...
 - ❑ Writing an email to parents
 - ❑ Signing the assessment reports
 - ❑ Attending an IEP meeting
- ❑ Post-nominal letters is a symbol of knowledge and expertise.
 - ❑ It is a seal certifying validity of what is shared



You're the Gold Standard

On the National Level

- ❑ The more CAPEs we have throughout the nation, the stronger our field becomes and more the prestigious the educational community views adapted physical educators.
- ❑ Currently in many areas throughout the country physical education teachers without any background knowledge can provide APE services because administrators in those areas lack knowledge for CAPE.

More CAPEs = Hiring of Qualified Professionals

Hiring of Qualified Professionals = Greater Student Growth

History:

Adapted Physical Education National Standards

In 1992, through a grant the National Consortium for Physical Education for Individuals with Disabilities (NCPEID) organization began to develop adapted physical education standards which was revised in 2020 and is in its 3rd edition.

APENS was then created in 1995 as a function of NCPEID to certify professionals in adapted physical education throughout the United States.



15 Standards:

1. Human Development
2. Motor Behavior
3. Exercise Science
4. Measurement & Evaluation
5. History and Philosophy
6. Unique Attributes of Learners
7. Curriculum Theory & Development
8. Assessment
9. Instructional Design & Planning
10. Teaching
11. Consultation and Staff Development
12. Student and Program Evaluation
13. Continuing Education
14. Ethics
15. Communication



Eligibility Requirements:

- ❑ A **minimum of 12 semester hours** specifically addressing the educational needs of individuals with disabilities. It is required that 9 hours be specific to the area of APE of meet the following criteria:
 - ❑ Satisfactory completion of a minimum of 9 credits in APE coursework and 3 credits of coursework from a related field.
 - ❑ Satisfactory completion of a minimum 6 credits in APE coursework and 3 credits in coursework from a related field as documented and up to 3 credits awarded for professional experience teaching APE as documented. (**Being Phased Out**)
- ❑ **Minimum of 200 hours** of documented experience providing physical education instruction to individuals with disabilities.
- ❑ A **current valid teaching certificate** in physical education.

Certification Provides:

- ❑ Certification is provided for 7 years
- ❑ You'll receive 1 free year membership to the NCPEID organization
- ❑ You'll receive 1 year free subscription of PALAESTRA
- ❑ You'll receive a certificate documenting your accomplishment
- ❑ You'll be able to identify as a CAPE with those initials indicated after your name

Recertification:

- ❑ Prior to the expiration of your certification, you'll want to you'll want to download and complete the recertification form:

- ❑ Part of the form requires you to show how you have stayed engaged in APE over the past years in most (not necessarily all) of the following areas
 - ❑ Elected Official or Board Member related to APE
 - ❑ Presentations or In-service
 - ❑ Professional Development
 - ❑ Licensure/Endorsement
 - ❑ Supervised Interns or Student Teachers in APE

Eligibility and Recertification Updates in 2021:

- ❑ In the new year, eligibility and recertification criteria will be updated.
- ❑ The 3 credits for professional teaching experience in APE will be phased out to reflect the proliferation of APE courses readily available to physical educators (significant changes since APENS was first introduced in 1997)
- ❑ The recertification criteria will be expanded to provide more options for CAPEs to earn points towards documenting their experiences.

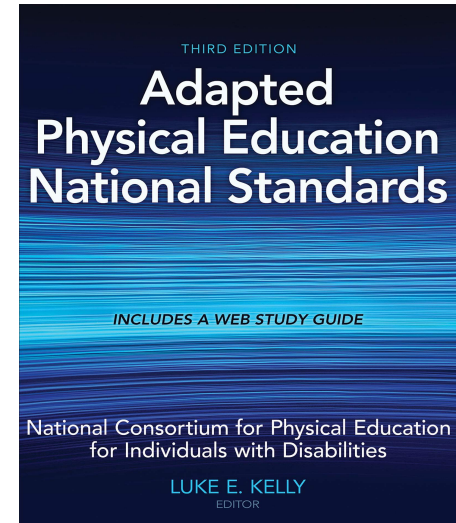

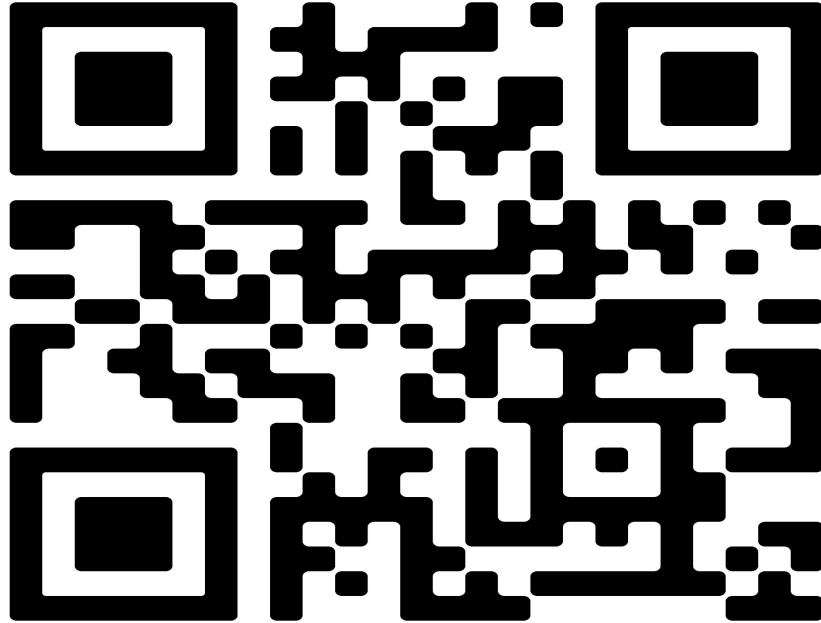
