## Code of Ethics

*For the National Consortium for  
Physical Education and Recreation  
for Individuals with Disabilities*

*The mission of the National Consortium for Physical Education and Recreation for Individuals with Disabilities (refer to as National Consortium) is to promote research, professional preparation, service delivery, and advocacy of physical education and recreation for individuals with disabilities. Each member of the National Consortium is committed to this mission and, as a reflection of this commitment, is responsible for behaving ethically in everyday professional practice. Expected ethical behavior is grounded in such factors as honesty, confidentiality, integrity, accountability, fairness, competence, diligence, responsibility, and respect. These factors are viewed within the context of the National Consortium's Code of Ethics which specifically states:*

- 1. All National Consortium members will engage in scholarly endeavors in an ethical manner. This includes areas such as use of data, confidentiality, authorship, treatment of research subjects, copyright law, and informed consent.*
- 2. All National Consortium members will engage in external grant and contract activities in an ethical manner. This includes areas such as grant reviewing, lobbying, conflicts of interest, grant writing, fiscal management, grant reporting, and dissemination of grant results.*
- 3. All National Consortium members will engage in professional relationships in an ethical manner. This includes areas such as anti-discrimination, student and faculty recruitment, use of official status and power, mentorship, and advocacy.*
- 4. All National Consortium members will engage in professional preparation activities in an ethical manner. This includes activities at both the preservice and inservice levels. National Consortium members also will commit themselves to life-long learning.*
- 5. All National Consortium members will engage in professional service activities in an ethical manner. This includes such activities as those associated with consulting, carrying out the duties of an appointed position or elected office, committee responsibilities, officiating sport, review of scholarly papers, the preparation and delivery of presentations, and systematic advocacy responsibilities.*
- 6. All National Consortium members will engage in direct service activities in an ethical manner. This includes related physical education and recreation activities in schools, at colleges and universities, and within the community associated with the education, training, and quality of life potential of all individuals, with and without disabilities.*

*In conclusion, all National Consortium members will neither participate in nor condone unethical behavior as reflected within this Code. Further, each member will be vigilant in preserving the National Consortium's integrity.*

## Capitol Report

SENATE VERSION OF IDEA RELEASED:  
AN UPDATE ON THE REAUTHORIZATION OF IDEA

The Senate released their version (staff discussion draft) of the Individuals with Disabilities Education Act (IDEA) Bill on November 20, 1995 and permitted 14 days for public comment. As an overview, this reauthorization draft intends to:

- \* Consolidate parts and sections of the bill, i.e., discretionary programs are potentially reduced to three main parts.
- \* Reduction of discretionary programs in half (14 down to 7).
- \* Amendments addressing violence and discipline regarding students with disabilities.
- \* Flexibility of states and LEA's in implementing the law.
- \* Restructuring of discretionary programs-linking them to state efforts to provide services in Parts A-H.
- \* Allows states to collaborate with other states to address systematic problems of regional or national basis.

Part D is proposed to house research, demonstrations, outreach, and personnel preparation grant authorizations. Part D will be closely linked to Part C which is a "Systems Changes" approach connecting federal, state, and local education agencies. Categories of funding appear to be: New Knowledge Production, Integration of Research and Practice, Improving the use of Professional Knowledge, High Incidence Disabilities, Leadership Preparation, Low Incidence Disabilities, and Projects of National Significance (as mentioned above). Maybe the title of Part D provides insight into the direction of the Senate Subcommittee on Disability Policy: "Improving Early Intervention, Transitional, and Educational Services and Results for Children with Disabilities through coordinated Research and Personnel Preparation."

Reference is continuously made to state-identified needs, linking state and local educational agencies, etc., meaning a significant shift from federal to state to local control of decision making regarding research - practice - preparation.

The Adapted Physical Activity Council (APAC), under the umbrella of the American Association for Active Lifestyles and Fitness (AAALF) and the National Consortium for Physical Education and Recreation for Individuals with Disabilities (NCPERID) are keeping up-to-date on these issues and will be responding to this current version of the bill.

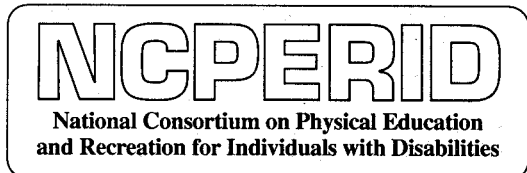

# NCPERID Conference Call MINUTES September 29, 1995

President, Gail Webster called the meeting to order and conducted the roll call of board members on line. The board members voted unanimously to approve the minutes of the July 17, 1995 board meeting. The board members voted unanimously to approve the 1995-1996 budget.

The committee reports were as follows: Liaisons: board members holding representative positions were assigned as liaisons to various organizations such as NTRS - Sarah Rich, CEC - Marty Block, and APAC (AAHPERD)- Jim Decker; Legislative: A legislative workshop will be conducted at AAHPERD and co-sponsored by AAALF with input from Jan Seaman; Awards: Barry Lavay will continue as chair for one more year of this committee. The Informational Meeting of NCPERID at AAHPERD has been tentatively set for Friday. The NCPERID sponsored social of APAC will be on Friday evening. Paralympics Congress has invited NCPERID members to participate in two consensus sessions. Individuals from various organizations will participate in these sessions that will lead to an action plan. NCPERID members must pay the conference fees of the Congress to participate in these sessions.

## ABSTRACTS

### A HEALTH-RELATED CRITERION-REFERENCED PHYSICAL FITNESS TEST FOR ADOLESCENTS WITH SPINAL CORD INJURIES

This presentation focused on the selection and development of health-related physical fitness test items for adolescents with spinal cord injuries. The approach described included a literature review to identify the health-related concerns which appeared to be amenable to change through physical fitness for this population. From the identified needs a desired physical fitness profile was developed which established goals for a physical fitness program. For each of these goals, test items which could be used to determine a youngster's present level of performance were discussed. A model of health-related fitness which could help to identify sources for criterion-referenced standards for the test items selected also was described.

### STIMULUS PROMPTING OF CHILDREN WITH AUTISM

Autism is a disabling life long condition characterized by severe communication, developmental and educational problems. In particular, "stimulus overselectivity" (i.e., when children with autism receive multiple stimuli, their behavior comes under the control of only a restricted range of stimuli) potentially can make teaching motor skills to such children extremely difficult. The purpose of this investigation was to compare two instructional models for teaching children with autism. One strategy, the extrastimulus prompt model, employed the use of extensive physical, visual and verbal prompts while the other strategy, the within-stimulus prompt model, emphasized only prompting which required the subject to remain ontask. Both instructional models were applied to a 14 level simulated ten pin bowling task. Subjects were six boys, between the ages of 5 and 9 years, who met the Diagnostic and Statistical Manual of Mental Disorders (American Psychiatric Association, 1987) criteria for autism. Results were equivocal. The Mann Whitney U Test revealed subjects who received the extra-stimulus prompt model did not perform significantly ( $p > .05$ ) better than subjects who received the within-stimulus prompt model. At the same time, visual analyses of data led to the conclusion that subjects who received the extra-stimulus prompt model performed clinically superior to subjects who received the within-stimulus prompt model. Similar to previous investigations, these results support use of an extra-stimulus prompt model when teaching motor skills to children with autism.

# National Consortium for Physical Education and Recreation for Individuals with Disabilities

## Purpose

The purpose of the National Consortium for Physical Education and Recreation for Individuals with Disabilities is to promote, stimulate, and encourage the conduct of service delivery, professional preparation, and research in physical education and recreation for individuals with disabilities. The Consortium provides public information and education, promotes the development of programs and services, and disseminates professional and technical information. The Consortium succeeds the National Committee on Physical Education and Recreation for Handicapped Children and Youth, formed in 1973, serving as a means of assuring the continuation of the pursuit of the aims, activities, and services of the Committee on behalf of the physical education and recreation needs of persons with a disability.

## Bylaws

### Article I

#### Membership

- Section 1. **Classes of members.** There shall be four classes of members: Individual Active Members, Organization Members, Honorary Members, and Ex-Officio Members. No one person may have membership in more than one class of membership.
- Section 2. **Active Members.** Individual active membership which includes student memberships and Life memberships is open, upon payment of the current membership fee, to any person—who is or has been previously involved in pursuing a professional career in physical education and/or recreation for individuals with disabilities.
- Section 3. **Organizational Members.** Organizational membership may be conferred by a majority vote of the Consortium members present at the annual meeting or appropriately scheduled official meetings. Accredited institutions of higher education, national, public or private agencies and national professional organizations who are supportive of the Consortium and are represented at least annually in Consortium meetings are eligible for consideration.
- Section 4. **Honorary Membership.** Honorary membership may be conferred upon any person who has made outstanding contributions to physical education and/or recreation for individuals with disabilities upon nomination by an active member and election by a majority of the active members at a scheduled meeting. Names of proposed candidates for Honorary Membership shall be submitted in writing to The Board of Directors at least thirty (30) days before election. Honorary members shall have all the privileges of active members.
- Section 5. **Ex-Officio Membership.** Ex-Officio membership shall be offered to a representative from the National Recreation and Park Association, the American Alliance for Health, Physical Education, Recreation, and Dance, The Council for Exceptional Children, and such other organizations upon recommendation by the membership committee. Membership shall be at no cost to the organization. The Consortium membership committee chair shall review and actively update ex-officio membership annually.

### Article II

#### Fiscal Year

The fiscal year of the Consortium shall begin on the first day of July and end the last day of June in each fiscal year.

## Article III

### Dues

- Section 1. **Annual Dues.** Upon recommendation of the Board of Directors, the Consortium membership may determine periodically the amount of the membership dues payable to the Consortium by the active and organizational members. Honorary and ex-officio members shall not be assessed membership dues.
- Section 2. **Payment of Dues.** Dues shall be payable in advance on the first day of July in each calendar (fiscal) year. The full current membership dues shall be applicable irrespective of the date of initial membership or payment for continuing membership.
- Section 3. **Default and Termination of Membership.** When any member shall be in default in the payment of dues for a period of three months from the beginning of the fiscal year, his or her membership may, thereupon, be terminated by the Board of Directors until such membership dues are paid.

## Article IV

### Meetings

- Section 1. **Annual Meeting.** There shall be an annual meeting of the members of the Consortium for receiving the annual report of the officers, directors, and committees, and transaction of other business at the date and location to be determined by the Board of Directors at least six months in advance of the identified date. Notice of the meeting shall be communicated to the membership through the newsletter, journal announcements, individual mailings and other appropriate mechanisms. All notices of the meeting shall set forth the place, date, time and purpose of the meeting.
- Section 2. **Special Meetings.** Special meetings may be called by the President, the Board of Directors, or by such officers or persons or members or proportion of members as may be provided in the bylaws. Notice for any special meeting is to be given as for the annual meeting. No business other than that specified in the notice of meeting shall be transacted at any special meeting of the members of the Consortium.
- Section 3. **Waiver.** Notwithstanding the provisions of any of the foregoing sections, a meeting of the members of this Consortium may be held at any time and at any place within or without the District of Columbia and any action may be taken there at, if notice is waived in writing by every member having the right to vote at a meeting.
- Section 4. **Quorum.** Approval of a majority of the members present and eligible to vote shall constitute the declaration of a quorum for the purpose of transacting Consortium business and at the annual meeting of other membership meetings.
- Section 5. **Inspectors of Election.** Two inspectors of election shall be appointed by the nominating committee chair prior to the first annual meeting and at each subsequent annual meeting. They shall act as inspectors of election at the annual meeting and for all special meetings or mail ballots until the next annual meeting.
- Section 6. **Voting.** Each active and honorary member shall be entitled to one vote. If the manner of voting on any question has not otherwise been prescribed, it shall be decided by a majority vote of the members present in person or by proxy.
- Section 7. **Proxies.** Every member of the Consortium entitled to vote at any meeting thereof may vote in proxy. A proxy shall be in writing and revocable at the pleasure of the member executing it.

Section 8. **Order of Business.** The order of business shall be as follows at all meeting of the Consortium, the Board of Directors, and the committee:

- a. Calling of the roll
- b. Proof of notice of meeting or waiver of notice
- c. Reading of the minutes
- d. Reading communications
- e. Reports of officers and new members
- f. Reports of committees
- g. Unfinished business
- h. New business
- i. Election of officers and new members

Any question as to priority of business shall be decided by the President without debate.

This order of business may be altered or suspended at any meeting by a majority vote of the members present.

## Article V Board of Directors

- Section 1. **Composition.** The Board of Directors shall consist of the Consortium officers and two members representing physical education and two members representing recreation, all of whom shall be elected by the Consortium membership. A representative of the Past-presidents will be an ex-officio non-voting member of the Board. The members of the Board, shall, upon election, immediately enter upon the performance of their duties and shall continue in office until their successors shall be duly elected and qualified.
- Section 2. **Method of Election and Term of Office.** The Consortium members shall elect the Board of Directors by mail ballot prior to the annual meeting. Members will be elected by a majority vote. Members of the Board of Directors representing physical education and recreation shall be elected for two-year terms. One member each from physical education and recreation shall be elected prior to each annual meeting. Approval of a majority of members returning ballots shall constitute a quorum necessary for election.
- Section 3. **Duties of Directors.** The Board of Directors may: (1) hold meetings at such times and places as it think proper; (2) appoint committees on particular subjects from the members of the Board, or from other members of the Consortium; (3) audit bills and disburse the funds of the Consortium; (4) print and circulate documents and publish articles; (5) carry on correspondence and communicate with other associates interested in the purposes for which this Consortium was created; (6) employ staff and consultants; and (7) devise and carry into execution such other measures as it deems proper and expedient to promote the objects of the Consortium and to best protect the interests and welfare of the members.
- Section 4. **Meetings of the Board.** Regular meetings of the Board of Directors shall be held immediately preceding and following the annual meetings of NRPA and AAHPERD. Notice of the meetings shall be communicated to the membership through the Newsletter, and/or other appropriate mechanisms. The President may, if deemed necessary, or the secretary shall, at the request in writing of three members of the Board, issue a call for a special meeting of the Board, and only five days notice shall be required for that special meeting.
- Section 5. **Quorum.** A majority of the members of the Board of Directors shall constitute a quorum for the transaction of business. In the absence of the president and vice president the quorum present may choose a chairperson for the meeting. If a quorum is not present, a lesser number may adjourn the meeting to a later day, not more than ten days later.

Section 6. **Absence.** If any member of the Board of Directors is absent unreasonably from two consecutive meetings of the Board without sending a communication to the president or secretary stating the reason for so doing, and if the excuse should not be accepted by the members of the Board, this seat on the Board may be declared vacant, and the chairperson may forthwith proceed to fill the vacancy.

Section 7. **Vacancies.** Whenever any vacancy occurs in the Board of Directors by death, resignation, or otherwise, it shall be filled without undue delay by a majority vote by ballot of the remaining members of the Board at a special meeting which shall be called for that purpose. The election shall be held within 60 days after the occurrence of the vacancy. The person so chosen shall hold office until the next annual meeting, or until his or her successor shall have been chosen at a special meeting of the members.

## Article VI Officers

- Section 1. **Number.** The officers of this Consortium shall be a president, a vice president, a secretary, and a treasurer.
- Section 2. **Method of Election and Term of Office.** The officers of the Consortium shall be elected each year prior to the annual meeting by mail ballot by the Consortium members. All officers will be elected and immediately serve in their elected position for a term of one year, except for the president who will serve a two-year term. A majority of the Consortium members returning ballots shall be necessary to constitute a quorum for election.
- Section 3. **Duties of Officers.** The duties and powers of the officers of the Consortium shall be as follows:

### PRESIDENT

The president shall preside at the meeting of the Consortium and of the Board of Directors and shall be a member ex-officio, with right to vote, of all committees. He or she shall also, at the annual meetings of the Consortium and such other times as he or she deems proper, communicate to the Consortium or to the Board of Directors on such matters and make such suggestions as may in his or her opinion tend to promote purposes of the Consortium and shall perform such other duties as are necessarily incident to the office of the president, including submission of an annual report to the membership.

### VICE PRESIDENT

In case of death or absence of the president, or of inability from any cause to act, the vice president shall perform the duties of the office.

### SECRETARY

It shall be the duty of the secretary to give notice of and attend all meetings of the Consortium and its several divisions and all committees and keep a record of their doings; to conduct all correspondence and to carry into execution all orders, votes, and resolutions not otherwise committed; to keep a list of the members of the Consortium; to notify the officers and members of the Consortium of their election; to notify members of their appointment on committees; and at his or her request give notice of the meetings of the committees; to prepare, under the direction of the Board of Directors, reports on the transactions and conditions of the Consortium, and generally to devote his or her best efforts to forwarding the business and advancing the interests of the Consortium. The secretary shall be the keeper of the Consortium Seal.

### TREASURER

The treasurer shall keep an account of all monies received and expended for the use of the Consortium, and shall make disbursements only upon vouchers approved in writing by any member of the Board of Directors. He or she shall collect the fees, annual dues and subscriptions. He or she shall deposit all sums received in an approved bank, or banks, or trust company, and make a report at the annual meeting or when called

upon by the president. Funds may be drawn only upon the signature of the treasurer.

The funds, books, and vouchers in his or her hands shall, at all times, be under the supervision of the Board of Directors and subject to its inspection and control. At the expiration of his or her term of office, he or she shall deliver over to the successor all books, monies, and other property, or, in the absence of a treasurer-elect, to the president.

Section 4. **Bond of Treasurer.** The treasurer shall, if required by the Board of Directors, give to the Consortium, such security for the faithful discharge to his or her duties as the Board may direct.

Section 5. **Vacancies.** All vacancies in any office, temporary or permanent, shall be fulfilled by the Board of Directors without undue delay at its regular meeting, or at a meeting specially called for that purpose.

### Article VII Committees

Section 1. **Committees.** At the first meeting or any regular meeting of the Board of Directors, the majority of the Board of Directors may designate and appoint committees to exercise the

authority of the Board of Directors in the management of the Consortium. The delegation thereto of authority shall not operate to relieve the Board of Directors or any individual director of any responsibility imposed upon it or him or her by law. The members of such committees shall hold office until the appointment of their successors.

Section 2. **Committee Quorum.** A majority of any committee of the Consortium shall constitute a quorum for the transaction of business, unless that committee shall by a majority vote of its entire membership decide otherwise.

Section 3. **Committee Vacancies.** The various committee chairpersons shall have the power fill vacancies in their membership.

Section 4. **Standing Committees.** The Adapted Physical Education National Standards (APENS) Committee will be appointed by the President. The committee will be responsible for overseeing policies, implementing and continuation of the APENS project.

### Article VIII Amendments

These by-laws may be amended, repealed, or altered in whole or in part by two-thirds of the active members present and voting at the annual meeting of the Consortium. The proposed changes are to be mailed to the last recorded address of each member at least thirty days before the time of the meeting.
